The Asian Conference on Nonlinear Analysis and Optimization (NAO-Asia) aims to provide a forum for researchers and practitioners interested in the topics related to nonlinear analysis and optimization, which takes place every two years. NAO-Asia has previously appeared in four versions. The first one was held on September 14–18, 2008 at Matsue City in Shimane, Japan, and the second one on September 9–12, 2010 at Phuket, Thailand. The third one was again held on September 2–6, 2012 at Matsue City, and the fourth one as a satellite conference for ICM 2014 was held on August 5–9, 2014 at National Taiwan Normal University in Taipei, Taiwan. The fifth conference one was held on August 1–6, 2016 at Toki Messe in Niigata, Japan. The upcoming Sixth conference (NAO-Asia 2018) will be held at OIST & ANA Intercontinental Manza Beach Resort in Okinawa, Japan on November 5–9, 2018.
